I would like to start by thanking Katy Kaylor, she has decided to step aside as Tournament Sanctioning Secretary effective immediately. Katy took over sanctioning when Clyde passed away and has done a great job for NAFA. Melanie and I will take over the duties of tournament sanctioning until a replacement for Katy can be trained.

At the July board meeting it was decided to increase the penalty for not submitting tournament results. This was made necessary because some tournament directors have not been returning results in a timely manner. With more people entering data we are able to keep stats up to date, but we can't if we don't have results. So please mail the results within the two weeks allowed for submitting.

NAFA is currently searching for a vendor to manufacture EJS we have budgeted money to purchase multiple sets of EJS. If you know of a company or an individual interested in manufacturing the EJS System contact me via phone or e-mail @ mca-voy5@home.com. We are currently investigating changing shippers for EJS to UPS, this would allow us to track shipments and also permits door to door service instead of airport pick up and drop off. As soon as we have started this new service all tournaments directors will be notified. With regard to EJS shipping, Dale Smith is stepping down as EJS coordinator in the U.S. and Todd Morningstar has volunteered to take over shipping the EJS in the U.S. I would like to thank Dale for all his work with shipping and also to Todd for volunteering to take over.

NAFA Board of Directors Meeting

Saturday, July 8th, 2000
Chicago, IL

All board members were present. The Executive Director, Steve McAvoy was also present.

The meeting was called to order by Alan at 8:37 a.m.

Alan asked that the minutes of the last Board Meeting on February 12, 2000 be reviewed for corrections and omissions.

Corrections to be made:

Connie Croley's request regarding three legged dog policy – Steve withdrew his veto. No change in the outcome.

In the NAFA News, vol 6 issue 1, bottom of page 5: Revise heading to now read "Letter regarding Judges excusing dogs that hit, break, or knock down jumps repeatedly".

Clyde Moore Memorial Hall of Fame – Steve's veto

stood. The motion did not pass – criteria for Hall of Fame stays as it is. In order to be inducted into the Hall of Fame a dog must have 50% or more of the vote returned.

Sue made the motion to adopt the amended minutes – seconded by Dale. The motion passed unanimously.

Steve reports that we are investigating the possibility of changing Electronic Judging System shipping carriers. United Parcel Service allows for a more flexible door to door pick-up and delivery instead of airport pick-up and delivery.

Steve commented on the increase of dogs being excused for aggression. Everyone needs to encourage their areas to not rush dogs into competition.

Steve commented on the increase of good media coverage NAFA has been getting due to the Globetrotter demos, Purina Challenge, and various team demos held throughout North America being televised and in print.

Steve noted that he needs to assign a new Tournament Sanctioning Secretary. Katy Kaylor has requested that she be replaced. Steve McAvoy will be temporarily taking over position. All sanctioning requests should be sent to the NAFA address.

Todd Morningstar will begin assisting in EJS shipping for the United States.

Review of 1999 Financial Report. Report will be included in the NAFA News.

Judges and Guidelines

Val made the motion that we approve Heather Pudington as a new NAFA Judge. Motion passed unanimously.

Val made the motion that we approve Carl Dingee as a new NAFA Judge. Motion passed unanimously.

Val made the motion that we approve Shaun Evans as a new NAFA Judge. Motion passed unanimously.

Val made the motion that we reinstate Joe Houlton as a NAFA Judge. Joe has fulfilled all requirements for re-instatement. Motion passed unanimously.

Judges Video, Promotional Video, Line/Box/Table Training Video – Val and Bob – First draft of the judge's video script has been written. It's currently being reviewed for input by several judges and board members. Val is currently working to schedule footage filmed for both videos in various regions. We would like to have the Judges video completed by November 2000. Currently, we have \$25,000.00 budgeted for the videos. We are looking to increase that by \$7,500.00. This is coming from the Petsmart sponsorship.

Treasurer – Dale is currently working on NAFA accepting credit cards (Visa, Master Card, Discover, American Express, and Diners Club) for obtaining CRN numbers via the flyball.org web-site. Requestors would fill in all required information, key in credit card number, and immediately be issued a CRN number. Dale hopes to have this in place by September 2000. At this time, NAFA does not plan to accept credit card payments through the mail and at a later time, the board will look into accepting credit cards for other fees.

NOMINATIONS For HALL of FAME!

Hall of Fame –Marion, Bob, and Robin – We have extended the nominations for Hall of Fame until **August 31, 2000**. Nominations should be sent to the NAFA Address or to flyball@flyball.org.

Acquiring EJS – Dale is currently pursuing working with Aaron Hughes to better understand the core of his EJS system. If his system fits with our future needs, it already has much of what we want. Val indicated that Aaron would be very willing to work with NAFA. Bob Long also proposed that he could develop the EJS and provide detailed drawings and documentation.

Petsmart Update – Alan stressed that next quarters budget requests are due. New ideas discussed included Media Packets, updated color brochures, web server as well additional funds for EJS and promotional video. Alan is verifying deadline for spending 1st budget period money. Unspent money must be returned.

Petsmart is reviewing whether they will continue to sponsor the Harlem Globetrotter Demos for 2001.

Staff Honorarium – Dale made the motion to budget up to \$500.00 per month to deliver to the Executive Director for allocation to his staff. Bob seconded. In favor, Val, Robin, Sue, Marion, Dale. Ule abstained – he is on the staff.

NAFA San Diego tournament – Bob – Reviewed status of NAFA/Petsmart sponsored tournament held in San Diego, CA along with the USDAA Agility trial.

Punishment and enforcement of punishment – Brett – Dale made the motion that the Executive Director has the authority to suspend or place on probation any club, person, or dog until the next scheduled meeting of the Board of Directors. Brett seconded. Motion passed unanimously. **Effective Immediately.** Will be added as 3.8 c under Probation.

Clubs forfeiting with two teams in the same division receiving no tournament points – Val – No action. Suggestion was made to re-arrange format of tournament and/or individual divisions.

Letter from Denise Delaney requesting assistance from NAFA for Supervising Judges assistance in Regions 9 and 13 – Alan – Sue made the motion that NAFA allocate \$1,000.00 to assist Regions 9 and 13 in the training of new judges. The funds are to be under control of the Judges & Guidelines Committee and will be available for use beginning July 2000 through May 2001. Seconded by Dale. In favor, Sue, Dale, Brett, Bob Long and Ule. Opposed – Marion and Robin. Motion passed. Alan absent – Val – acting Chairperson. Val to respond to Denise.

Tracking, distribution, and confirmation of the NAFA EJS – Brett – Clubs would like to know where their lights are coming from and where they are going too. We decided to add wording to the tournament letter that would set better expectations. They won't hear anything unless there is a problem. We will also begin asking the shipping team to call the receiving team and let them know they are on the way.

Club names and NAFA seeding chart – Alan – Alan inquired on teams consisting of the same dogs under different team names did not occupy multiple positions in the seeding chart. Steve gave an example of one. Dale will investigate.

Annual General Meeting – Alan is working to get a tournament set-up in Texas to be held in conjunction with the NAFA Annual meeting.

Letter from Stacy Santarone regarding foamcore jumps – Alan – Alan to respond requesting a sample.

Regional Championship criteria – cap on the 80% rules – Brett – Discussion included brackets based on number of tournaments in a given region, as well as tournament or weekend based caps. Val, Sue, and Brett will look into.

Media Package to be made available to teams hosting tournaments – Val is working on quotes to get basic press kit folders, 12 sheets of paper (photos, press releases, overall description of flyball, who is NAFA). This will be added to the 3rd quarter Petsmart budget. As the currently supply of NAFA brochure are very low, Brett & Sue will work to produce a new, updated brochure. This will also be added to the 3rd quarter Petsmart budget.

At this point in the meeting, Robin Marion exited for the remainder of the meeting.

Existing supply of NAFA Rulebooks - Dale made the motion that the current stock of existing NAFA Rule Books be destroyed. Bob made the second. The motion carried unanimously.

Tournament Result/Funds not submitted to NAFA within the specified period – Brett made the motion that NAFA institute a late fee when tournament results and fees are not submitted within 14 days. 15 plus days, up to one calendar month a late of \$50.00 will be charged. Beyond one calendar month up to two calendar months a \$100.00 late fee will be charged. Greater than two calendar month's late, the team is put on probation for a period of 1 year. Greater than 3 months late the team is put on suspension. The suspended team would need to request reinstatement from the Board of Directors. Val seconded. In favor, Brett, Val, Sue, Bob, Dale, Ule. Against – Marion. Absent – Robin. Add to Section 5.1 m. Rename current Section 5.1 m to 5.1 n.
